agroforestry systems of the Mediterranean climate regions, its planning and implementation, but also on the participatory planning of climate adaptation at farm level and municipal level, both on the agriculture and forestry sectors but also on coastal adaptation and community development. One of his most interesting present ventures is the facilitation of a Consortium Benchmarking with farmers leading to a community of practice on the topic regenerative pastures, using Keyline design and Holistic Management. In the recent years he has co-lead and co-developed interesting works such as: i) planning the climate adaptation of the agriculture and forestry on one municipality (Mértola); ii) planning three and managing two large conservation agroforestry farms (FCUL, Micélio, and EDIA); iii) developing, testing and publishing new frameworks and participatory methods for adaptation planning of agriculture and forests; iv) developing a landscape plan for a village condominium, with the community for fire prevention (with TerraCrua); v) training and coaching a H2020 consortium to implement Consortium Benchmarking on energy communities (in ECOLISE). As main facilitator he collaborates with EIP AGRI since 2019, namely in the Agri-innovation Summit 2019 entitled "EIP leading the Transition to Agroecology", EIP AGRI workshops "Shaping the EU mission 'Caring for soil is caring for life'" (2020) and "Towards Carbon Neutral Agriculture" (2021). André Vizinho has copublished 30 papers, technical reports and books in his PhD studies and research work, after graduating in Environmental Engineering (2003) and obtaining a master on economic viability of the sustainable management of cork oak forests.
