
Good practices collected

- In 16 initiatives forest-owners, their associations and other stakeholders (e.g., municipalities, environmental NGOs, local citizens, research institutes, other) worked together in partnership,
- Various levels of cooperation from local to cross-border and EU level.





Good practices – level of cooperation








Good practices – type of initiative


- Provision of funding mechanism and guidelines for forestry measures
