- > 22 responses



    - > Complementarity and coordination with Regional and Social funds, increasing the added value of EU funds for territorial development.





- Capacity building for all stakeholders along the decision-making chain: not just people in charge of CAP CSP implementation, but also COM desk officers to bring them the agricultural and rural reality closer of the MS that they are in charge of.


