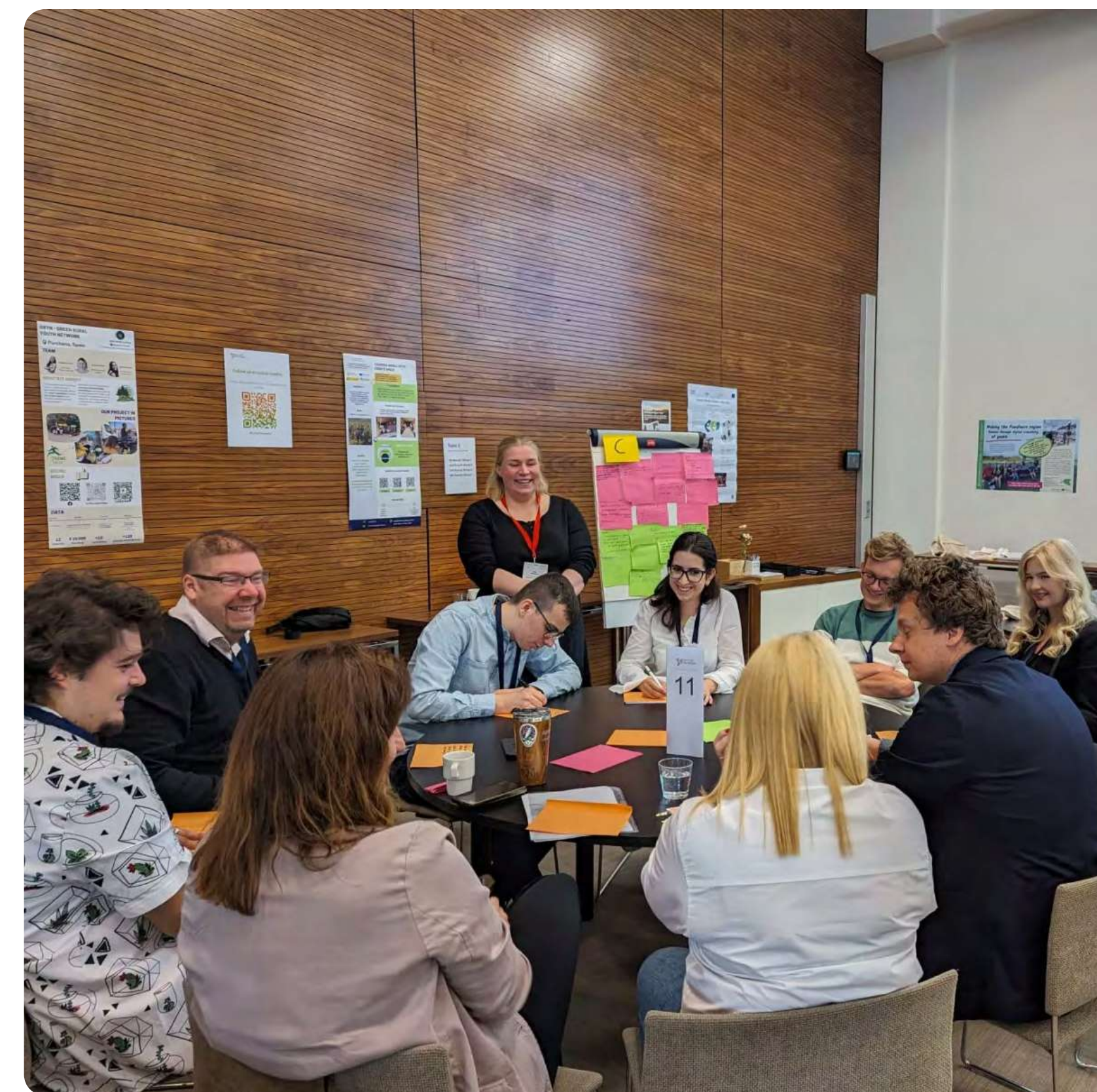

This Annual Work Programme is the result of the consultation of EU CAP Network stakeholders.

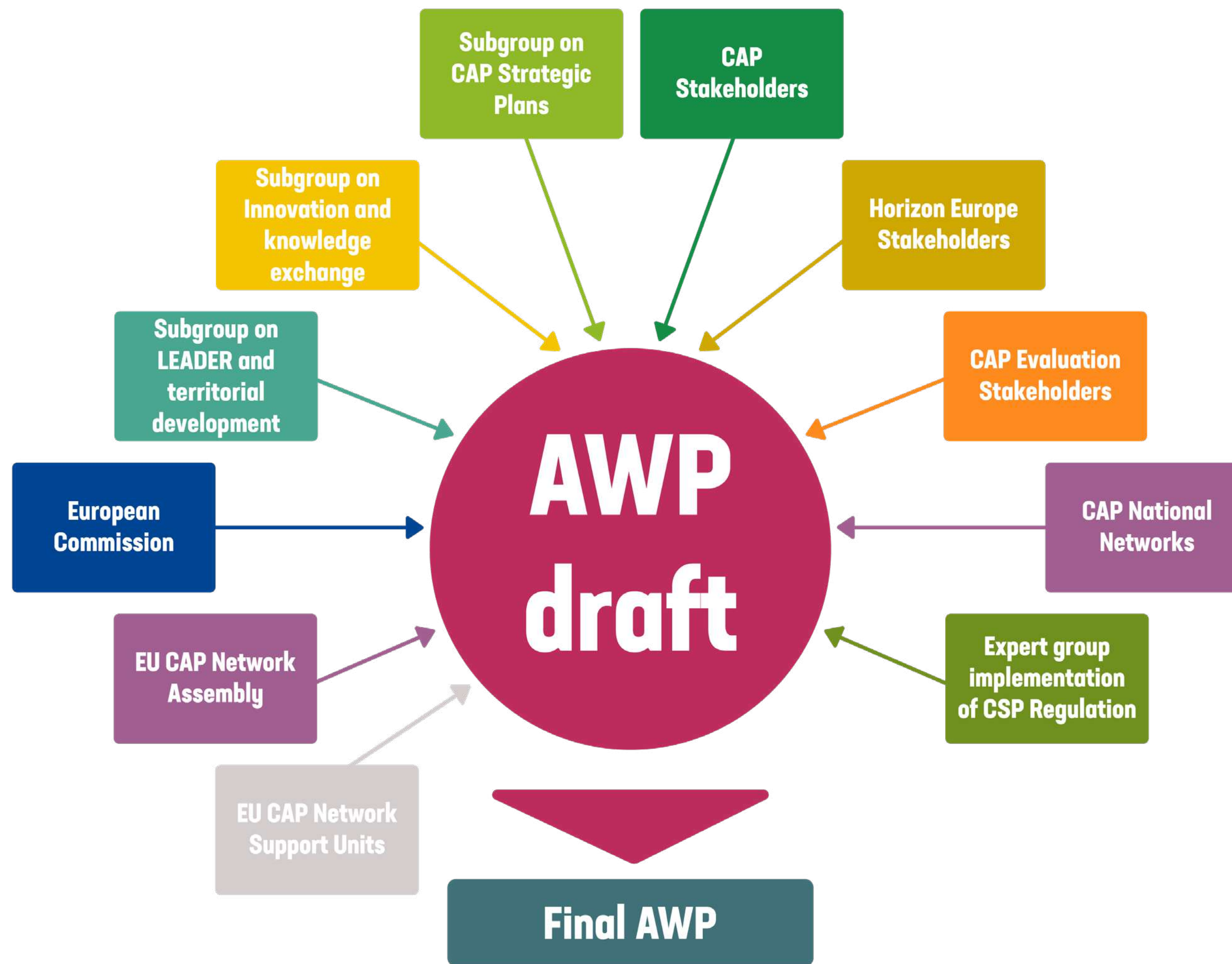

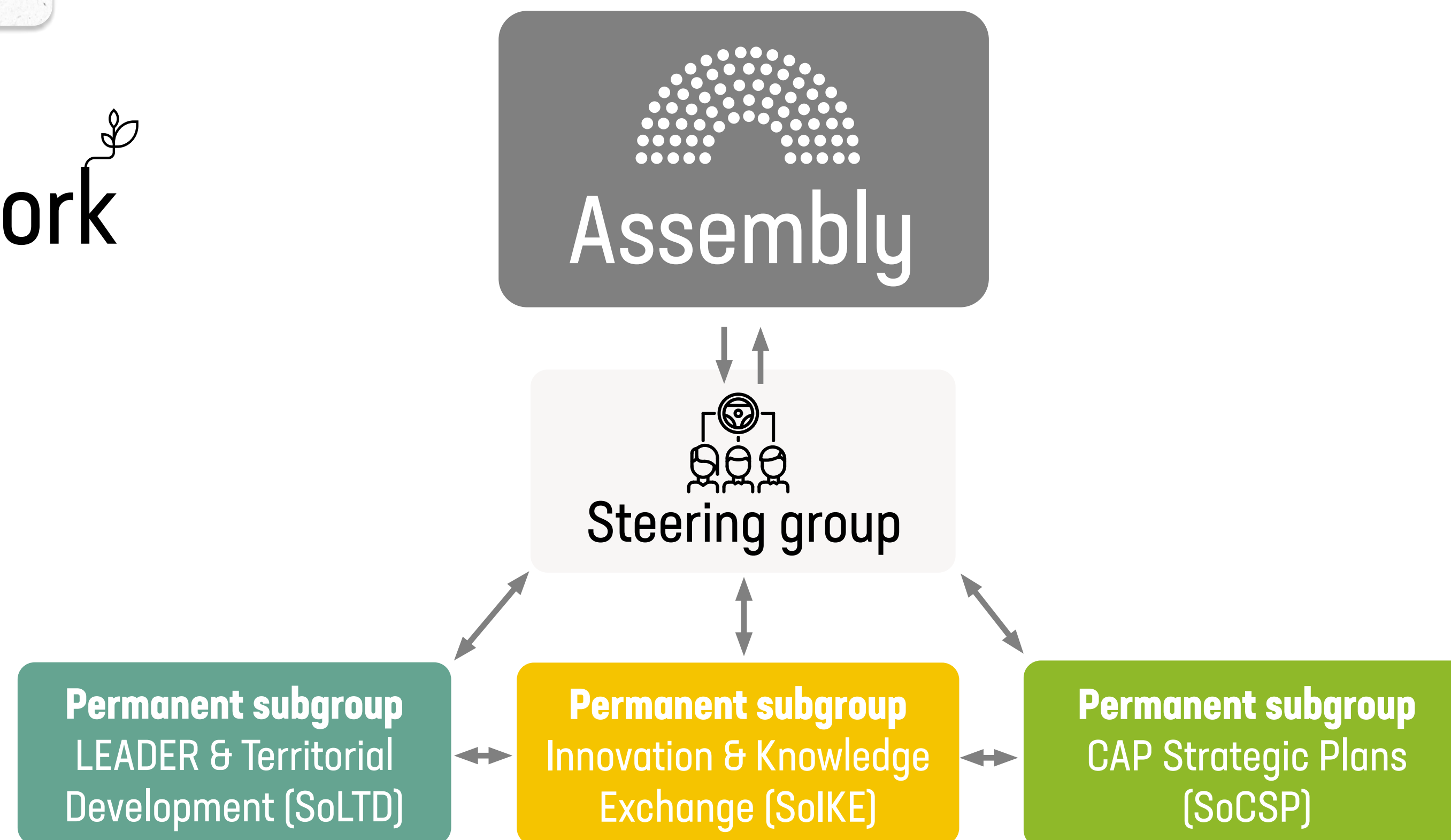

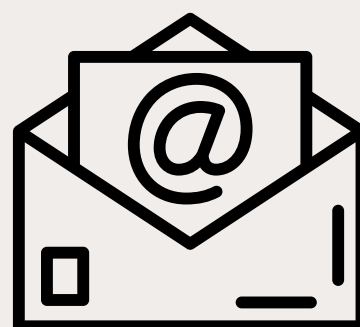
