### LEADER implementation in RDPs (2014-22)




## Absorption of LEADER measure in RDP 2014-22 (%)



80% of LEADER funding disbursed

Yet in Bulgaria, France, Italy, Slovakia: less than 70%





### LEADER in RDPs 2014-22 (EU27+UK)

(based on AIR 2023)

8 billion EUR (of EAFRD), of which 6,4 billion EUR disbursed so far (end 2024)

2,728 Local Development Strategies implemented

60% of EU rural population covered

72,000 jobs created

31% of rural population benefitting from improved services

## LAGs at work to implement their strategies 2023-27... but some delays

LAGs should be able to fulfill their tasks one year after approval of CAP plans (=end 2023)

The situation is nuanced with some delays: even though the vast majority of EU LAGs have been selected (except SK and BG), many have been paid for running costs, but fewer LAGs already opened calls for projects

Full picture is expected in the annual reports for 2024 but some information present in the survey



#### LEADER is at work in the CAP Plans – results of the survey

#### LAGs selected

BE-VL (15), CY (4), DE (372), EL (50), HR (56), HU (105), FI (53), LT (49), LUX (5), LV (33), EL (50), NL (31), PT (58), SI (37)

LAGs received at least one payment or advance (for running costs)

BE-VL (13), CY (0), DE (370), EL(0), HR (56), HU (62) FI (53), LT (48), LUX (4), LV (33), NL (28), PT (6), SI (37)

### LAGs received at least one payment (for projects)

LT (39), LUX (4), LV (18), BE-VL (3), NL (17)

LAGs with open calls for projects

BE-VL (15), DE (370), HU (9), FI (53), HR (11), LT (45), LUX (5), LV (33), NL (30), SI (31)

Selection not completed: SK, BG

The survey will be kept open and the MS are still invited to complete it.





#### Simplification in LEADER (survey)

#### Use of simplified cost options

BE-VL (microprojects, regular projects, staff costs), DE (staff costs), EL (construction costs), FI (all kinds of projects), LUX (umbrella projects), LT (all projects), LV (small projects for business, youth initiatives, cooperation projects), running costs (all MS except NL)

#### Advance payments to projects/running costs

Cooperation projects (DE, EL, FI, LT, LUX, SI); Local projects (HU, NL, PT) Running costs (PT, LV\*, FI\*, HR, LT, HU, NL, EL, DE)

Discussions on simplification to be continued at the annual review meetings...

#### Other simplifications

Procedures/reporting (FI), Forms (LUX), IT tools to reduce documentation (BE-VL), EL (de minimis for private projects), simplified payment claim for small projects (NL), less docs (CY), standard forms for monitoring (LT), simpler docs (HR), simpler rules on conflict of interest (DE)

#### Obstacles to simplification

Limited deeper understanding of bottom-up approach
Cost of engagement-bottom-up approach
Limited proportionality (small projects – controls)
Many irregularities even projects are small
Hard to set up SCO for small programmes
Audit requirements (EU/national)
National environmental/building laws (DE)




## First monitoring data on LEADER (DME) in CAP Plans 2023-27

Data covers 22 Member States (except: Spain, Slovenia, Slovakia, Bulgaria, Malta, Ireland (partly) and includes 2,036 LAGs (out of 2,633 planned)



## Added value of LEADER: extensive LEADER networks in rural EU and real participative democracy

30,000 local public authorities


21,000 other partners

25% of LAG members or 29,000 members are directly involved in decision making bodies




### Women in LAGs' decision making bodies (%)
